

## Public Call for Request for Information (RfI) for Producers, Suppliers and Installers of products and materials for energy efficiency (EE) measures

Pristina, February 6, 2020

## **BACKGROUND:**

The Subsidies for Energy Efficiency in Kosovo (SEEK) is an MCC-supported project, implemented by MFK with the GFA/HPC Consortium as Implementing Consultant (IC).

SEEK aims to provide incentives in the form of grant to energy consumers in the residential sector to invest in energy efficiency (EE) retrofits to reduce energy consumption, as well as incentives aimed at increasing the involvement of women in energy sector business opportunities, and energy efficiency investments.

The primary technical focus of SEEK are energy efficiency measures (improvement of thermal insulation, windows/doors, more efficient heating systems, etc.) that will reduce the consumption of electricity for heating and promote the use of energy efficient heating devices. Household Efficiency Retrofits (HER) is one of the Intervention Packages of SEEK focused on providing financial incentives to the residential sector.

HER intervention package (HER IP) will provide grants, with the total amount up to \$ 10 million, to individual houses and individual apartments within multi-apartment buildings for implementing energy efficiency measures.

The following EE measures will be implemented in individual HER sub-projects:

Energy-efficient heating systems (biomass boilers, stoves and furnaces, heat pumps: air-air, air-water, water-water, ground-water, etc.);

Thermal insulation of walls, floors, roofs, attic floor, basement ceiling, etc.;

Replacing of old with new energy-efficient windows and external doors;

- Energy-efficient domestic hot water systems (including solar thermal
